I am adopting the above cat from Friends of Feral and Homeless Cats and Kitten, Inc. I agree to accept full responsibility for the care and well being of the cat(s) and agree to the following conditions of adoption.

1. I am adopting the pet in my name and I will be its legal owner. I am not adopting the pet for someone else nor giving the pet as a gift to someone else.
2. If I find that I can no longer keep the pet I will return it Friends of Feral and Homeless Cats and Kittens, Inc. I WILL NOT SELL, GIVE AWAY, ABONDON OR RELINQUISH THE CAT(S) TO ANY PERSON, SOCIETY OR OTHER GROUP.
3. The Cat will NEVER BE USED FOR RESEARCH PURPOSES.
4. The cat will NEVER be declawed.
5. A Friends of Feral and Homeless Cats and Kittens, Inc. representative may examine the pet at any reasonable time and, if not satisfied with the care which I am giving to the cat or the conditions under which it is kept, may remove the cat from me.
6. If I believe the cat is lost I will immediately make every effort to find it. In that event I will advertise for the cat's return in local newspapers for a minimum of 2 weeks.
7. I understand that the cat will be spayed/neutered prior to leaving Friends of Feral and Homeless Cats and Kittens, Inc. Kittens will not be allowed to leave the sanctuary until they reach the age of 12 weeks, have been spayed/neutered and received their rabies vaccination.
8. I will obtain routine veterinary care for the cat(s), including periodic vaccinations (distemper, rabies, etc.). In the event of sickness or injury I will immediately obtain veterinary treatment for the cat(s).
9. I will notify Friends of Feral and Homeless Cats and Kittens, Inc. promptly of any change in my address or telephone number.
10. In the event I fail to care for the pet properly or otherwise breach this contract, Friends of Feral and Homeless Cats and Kittens, Inc. will be entitled to retake possession of the pet through any peaceful or legal means. In the event I don't comply with this contract and Friends of Feral and Homeless Cats and Kittens, Inc. has to bring a lawsuit as a result, I will reimburse Friends of Feral and Homeless Cats and Kittens, Inc. for its lawyer's fees and costs in doing so.

I understand that Friends of Feral and Homeless Cats and Kittens, Inc. has made no representations or warranties with respect to the cat including, without limitation, its health, temperament or training and I therefore accept the pet AS IS and WITH ALL FAULTS. Accordingly, I release Friends of Feral and Homeless Cats and Kittens, Inc. from all liability associated with the pet once I take possession of it.
